### 1. What forms of legally recognized relationships are available?

The Registered Partnership Act (*Eingetragene Partnerschaft-Gesetz*), published in Austria's *Federal Law Gazette (Bundesgesetzblatt)*, Volume I, Number 135/2009, made registered partnerships available exclusively to same-sex couples as of January 1, 2010. However, the relationship provides limited rights and is legally inferior to marriage in several ways.

Also, while couples in registered partnerships have had the same adoption rights as opposite-sex couples since January 1, 2016, in accordance with the Austrian Constitutional Court's decision that the country's adoption restrictions for same-sex couples were unconstitutional, the applicable law was never changed. Instead, Austria's Justice Minister announced that the law banning adoption by same-sex couples would no longer be enforced.

**2. What are the requirements to be able to enter into the above relationships?**

(i) Geographic requirements:

Registered partnership	Austrian law does not require a period of residence in Austria prior to the contracting of a registered partnership.

(ii) Other substantive eligibility criteria:

Registered partnership	<ul style="list-style-type: none"> <li>• A minimum of two witnesses is legally required.               <ul style="list-style-type: none"> <li>- Both parties in the partnership must go before a registrar and state their wish to enter into a registered partnership.</li> <li>- Parties can choose to have one, two, or no witnesses present before the registrar.</li> </ul> </li> <li>• Both parties must be at least 18 years of age, or if one party is at least 18 and the other is 16 or 17, each party must have parental consent.</li> </ul>

**3. If both marriage and civil unions exist:**

- (a) Identify any significant differences in eligibility; and
- (b) Briefly highlight how they interact if both are in effect (e.g., in some countries, entering into a marriage with the same or a different person automatically dissolves any civil union that the two parties were previously party to, making the latter vulnerable and potentially circumventing separation laws).
- (c) If both marriage and civil unions are available to same-sex couples, briefly highlight areas where major differences exist between marriage and civil unions (e.g., taxes, adoption, immigration, etc.).

Registered partnership	Applicants for a registered partnership must be single or provide proof of the dissolution of any prior marriage or registered partnership.

FORM OF LEGAL RELATIONSHIP	REQUIREMENTS
Marriage	<ul style="list-style-type: none"> <li>Foreign same-sex marriages or other relationships are recognized and treated as registered partnerships in Austria.</li> </ul>
Registered partnership	<ul style="list-style-type: none"> <li>Couples who seek to enter into civil unions or have their foreign civil unions recognized must register their unions at the municipal office or the magistrate's office.</li> </ul>

**6. How can each form of relationship be dissolved? What is the residency requirement or other link to Austria for an authority to grant a divorce/ dissolution?**

FORM OF LEGAL RELATIONSHIP	REQUIREMENTS
Registered partnership	A registered partnership may be dissolved if the partners have been separated for more than three years.
