¹ Northern Cyprus (also known as the “Turkish Republic of Northern Cyprus”) remains a *de facto* divided territory occupied by Turkey since 1974. The EU has not formally recognized Northern Cyprus, but a Turkish-endorsed government controls Northern Cyprus as a sovereign jurisdiction.

2. What are the requirements to be able to enter into the above relationships?

(i) Geographic requirements:

Civil union	There are no geographic residency requirements to enter into civil unions in Cyprus.

(ii) Other substantive eligibility criteria:

FORM OF LEGAL RELATIONSHIP	REQUIREMENTS
Civil union	<p>Under Sections 5 and 11 of the Republic of Cyprus Civil Union Law of 2015 (184(I)/2015):</p> <ul style="list-style-type: none"> i) A person must be at least 18 years of age to enter into a civil union; ii) A civil union cannot be contracted between: <ul style="list-style-type: none"> a) Direct- or indirect-line blood relatives up to the fifth degree; b) Relatives by direct or indirect line of affinity up to the third degree; or c) An adopted and an adopting person or their descendants.

3. If both marriage and civil unions exist:

- (a) Identify any significant differences in eligibility; and
- (b) Briefly highlight how they interact if both are in effect (e.g., in some countries, entering into a marriage with the same or a different person automatically dissolves any civil union that the two parties were previously party to, making the latter vulnerable and potentially circumventing separation laws).
- (c) If both marriage and civil unions are available to same-sex couples, briefly highlight areas where major differences exist between marriage and civil unions (e.g., taxes, adoption, immigration, etc.).

FORM OF LEGAL RELATIONSHIP	REQUIREMENTS
Civil union	A person cannot contract a civil union if he or she is currently married or is a partner in another civil union.

FORM OF LEGAL RELATIONSHIP	REQUIREMENTS
Civil union	The Republic of Cyprus recognizes civil unions legally entered into outside the Republic. Republic of Cyprus Civil Union Law of 2015 (184(I)/2015), § 43.

6. How can each form of relationship be dissolved? What is the residency requirement or other link to Cyprus for an authority to grant a divorce/ dissolution?

FORM OF LEGAL RELATIONSHIP	REQUIREMENTS
Civil union	<p>Under Section 17 of the Republic of Cyprus Civil Union Law of 2015 (184(I)/2015), a legally contracted civil union can be dissolved by:</p> <ul style="list-style-type: none"> i) A written joint statement before the registrar who granted the civil union; ii) An order of the court of the district in which the civil union was contracted, issued at the request of one of the partners; or iii) The two partners' contracting a marriage. <p>At the request of either partner, a civil union that was contracted despite the requirements of Sections 5 and 11 of the Republic of Cyprus Civil Union Law of 2015 (184(I)/2015) not having been met can be dissolved within three years of its creation by an order of the court of the district that granted the civil union. Republic of Cyprus Civil Union Law of 2015 (184(I)/2015), §§ 13–14.</p>
